"Turning agricultural activities into business"

INTRODUCTION

Inclusive agribusiness creates mutually beneficial business partnerships with smallholders in developing countries.

The 4th Annual African Women in Agric/Agribiz Summit 2016 -will address the full agribusiness spectrum from farming to forestry to animal husbandry and fish farming, in which the private sector can collaborate with smallholders along the value chain. Companies may source cash crops, staple crops or high value crops from smallholders. They may also sell inputs such as seed, feed, fertilizer, irrigation systems or machinery to smallholders in such a way to increase production and incomes and thus stimulate further demand. This in turn will create opportunities for employment, entrepreneurship and the creation of micro, small and medium sized enterprises. In our previous Summits we focused on empowering women for inclusive growth and strengthening the voice of women within the agricultural value chain. This year we are going to focus on "Turning Agricultural Activities into Business" This year's Summit will cover a wide spectrum in a sense that it will address current challenges and solutions facing women.

Traditionally, African women have fed their families through subsistence farming and are the labour mainstay on agricultural land, providing about 70% of farm labour. At the African Union Summit in Malabo, Equatorial Guinea in June 2014, Heads of State and Government adopted a remarkable set of concrete agriculture goals to be attained by 2025. The Malabo Summit reconfirmed that agriculture should remain high on the development agenda of the continent, and is a critical policy initiative for African economic growth and poverty reduction. In his 2016 budget speech, Minister Pravin Gordhan reiterated that initiatives to transform ownership of land and improve productivity in agriculture are under way and Ministers Zokwana and Nkwinti are addressing drought-related challenges in rural areas. He also stated that the Land Bank has set aside a concessionary loan facility to assist farmers in recovering from the impact of the current drought conditions. Over the next three years R15 billion is allocated for land acquisition, farm improvements and expanding agro-processing opportunities. But the real challenge for Africa's women farmers is how to turn their activities into businesses that provide sustainable income. However for this to be possible inclusive business in the form of partnerships is essential.
